4NTR - We're installing Message Deposit Boxes in the local Marine Corps Exchange. A box, plus a supply of blank message forms with instructions for their use, is offered as a convenience to local personnel to send a QTC without having to visit the station. Might be a useful idea for some of your stations. Good for business and all that, ya know.

Another hint that may be of value: Standard arrival texts, similar to those used at 6YDK, to be sent by personnel newly arrived on station,. Helps with the home ties, public relations, etc.. We're very anxious to get this system in operation at MCRD, Parris Island, too. Making these services available to newly arrived Recruits would make for a lot of happy parents when they" receive word of their son's safe arrival. Much faster than to 'write at the first opportunity'. Again, it's good public relations.

## OPERATING TIPS

## EXAMPLE?

W4NTR - FCC Regulations require complete identification of stations involved whenever contacts are initially made and completed, plus each ten minutes if the contact is lengthy. So; make a complete identification, and do it correctly. "KH6BGS, this is W4NTR". Brevity is nice, but don't get in such a hurry that the result comes out as, "BGS, 4NTR". Just ain't legal. Ref: FCC Rules and Regulations, Part 12, Seco 12.82.

So we're back in business. Depending of course, on how well ZERO BEAT is received, we'll stay with it. Just trying to help, and as previously mentioned, to 'add a little class to the jernt'. Hope we can be of service, even with the necessary limitations, to all concerned with the Amateur Radio Service within the Marine Corps.
